MEMORANDUM FOR DISTRIBUTION

SUBJECT: 2012 Fort Sill Intramural Golf Memorandum of Instruction

1. PURPOSE.

This memorandum, IAW USAFCOEFS PAM 215-1, prescribes the procedures and rules for conducting the 2012 Fort Sill Golf season.

2. GENERAL.

a. The 2012 Fort Sill Golf season will be scheduled as follows:

Entry (LOI) Suspense **Team Captains Meeting** **Post Championships**

Tues, 24 Apr 2012

Thurs, 26 Apr 2012

9 - 10 Jun 2012

b. Team Captains meeting will be held at 1130 hrs on Thurs 26 Apr 12 at the Fort Sill Golf Course.

3. ELIGIBILITY and TEAM COMPOSITION:

a. IAW USAFCOEFS PAM 215-1, Para 7, page 3.

b. Participation is unlimited.

c. Teams are limited to a roster of four (4) members and one alternate.

4. LEAGUE RULES:

a. Play will be governed by the 2012 United States Golf Association (USGA), unless amended by this MOI.

b. League play will consist of a 4 man scramble. All four players hit from the tee, of the four golf balls, players will then hit from the best position of all four until completion of that hole.

c. League play will consist of 1 round of 18 holes per week, beginning Tuesday 1 May 2012 and concluding Thursday 6 June 2012. Must play every week, no makeup dates allowed unless weather interferes with regular play.

d. The scorecard is kept for each foursome. The first person to tee off in the foursome will be responsible for the scorecard. Score card must be signed and turn in to pro shop, must have unit / battery of team on the card.

5. POST CHAMPIONSHIP TOURNAMENT:

- a. A two day, 36 holes tournament will be conducted 9 - 10 June 2012.
 - b. Tournament format will consist of 4 man scramble.
 - c. Overall Post tournament Champion will be determined by lowest score.
 - d. In the event there is a tie at the end of the Post Championship Tournament, the Post Championship will be determined by a scorecard playoff from Sunday scorecard.
 - e. In the event the Post Championship Tournament is cancelled due to inclement weather, the Post Champion and Runner-Up will be determined by the following: **Total Stokes**
6. EQUIPMENT: Players are responsible for providing their own equipment. If they do not have equipment,, the Fort Sill Golf Course has equipment available for rent.
7. CONDUCT and PARTICIPATION: IAW USAFCOEFS PAM 215-1, Para 14, page 8.
8. RESPONSIBILITIES:
- a. Fort Sill Sports, Fitness and Aquatics Branch:
 - (1) Responsible for the payment of green fees for non-members participating in the Fort Sill Intramural golf season and the Post Championship Tournament.
 - (2) Posting of scores following each round.
 - (3) Purchasing of Awards
 - b. Participants:
 - (1) Responsible for the payment of a cart, if necessary.
 - (2) Responsible for turning in correct scorecard following each round.
 - (3) It is the responsibility of all participants to be familiar with, and conduct themselves IAW the contents of these by laws.
9. AWARDS. 1st, and 2nd place team and individual trophies will be presented afterwards of the Post Championship Tournament.
